SPRING MEETING 2016

The Spring Meeting will be held on May 22, 2016, at 1 p.m. at the Pear Street Pavilion.

Below is an update from Del and three items that will need to be voted on.

I met with Ron Kirchhoff on March 22nd. Mr. Kirchhoff has committed to a **3-year deal** where he will fund **\$10,000 per year** toward our lake management projects, after which, we would discuss future funding from him. But, here's the deal-**we too** have to make a long term financial commitment. As I mentioned at our presentation when we voted on the 3-year lake assessment, there will be maintenance requirements on these projects and other projects need to take place as well. We are near the end of the three years and we need to look toward funding this in the future. The best way to fund this is to vote yes for a dues increase, which would dedicate funds to the lake and roads each year. The details of this important proposed increase are explained in full, and follow my update in this newsletter.

A vote of no would ensure that everything spent so far will have been wasted! Our current budget will not allow for maintenance of any of these projects. A no vote will also mean no more financial assistance from the Kirchhoff's! It is absolutely critical that we maintain this relationship with the Kirchhoff's. Only you can make this happen by voting yes for this increase.

You have been very supportive of our efforts up to this point, and if you want to insure the quality of our lake that we all enjoy for future generations, now is the time to make it happen. Representatives from Lake Management and roads will hold an informational meeting on May 14th at 11 am. This is one week before you will be voting on this issue. Please plan to attend this meeting so we can answer your questions at this time.

NOTICE OF PROPOSED DUES INCREASE

A dues increase of \$100 per year has been proposed and accepted by the Board of Directors at the February 21, 2016, board meeting. The proposed annual dues will be \$250 per member per year regardless of the number of lots owned (rescinding the \$15 per extra lot over 5) beginning in the 17-18 fiscal year, after the lake management assessment is finished.

For 2 years, members paid a minimum of \$275 for dues and the road assessment; then for 3 years, members, will have paid a minimum of \$250 for dues and the lake assessment. Therefore, for 5 years, members will have been paying a minimum of \$250 per year in dues and assessments.

\$437,071.59 has been invested in our roads since 2012. \$119,417.87 has been invested in lake management since 2012. Without a dues increase, we will not be able to maintain the improvements that we have worked so hard for and invested so much in. All of the time and money spent will have been for nothing. This proposed dues increase will allow LLPOA to allocate a percentage of dues collected to Road Maintenance and Lake Management each fiscal year.

At the end of each fiscal year, Road Maintenance will receive 25% of the dues collected and Lake Management will receive 20% of the dues collected for use in the following fiscal year. Projected amounts for the 18-19 fiscal year are Lake Management \$15,150.00 and Road Maintenance \$18,937.50. This allows the Road Maintenance and Lake Management to be removed from the budget. In addition, Silt Ponds and Fish/Water Quality will be incorporated into the Lake Management removing them from the budget. The proposed dues increase will make available approximately \$8,220.50 for the general budget.

The following table shows how the dues increase will affect the budget.

To obtain an absentee ballot, you must request a ballot in writing. Send your request to LLPOA, PO Box 8, Bernard, IA 52032. Your absentee ballot must be returned by certified mail and received by LLPOA before May 22, 2016. **Only members in good standing are eligible to vote.**

As of 01/03/2016 reads;**ARTICLE IV—DUES AND SPECIAL ASSESSMENTS**

A payment plan, in writing and signed by the member and the Treasurer, may be entered into, to arrange payment of dues and special assessments, assessments, and penalties in installments over a specific period of time, and at intervals. In order to be valid under this subsection, such payment plan must contain the specific dates upon which payments are due, and the precise dollar amount due on each date. If a member defaults on such a payment plan, the entire balance, including any unpaid dues, special assessments and penalties, shall be due and payable in full 30 days of the mailing notice of default to the member, or within 30 days of personal delivery of said notice to the member by a member of the Executive Board. Beginning 30 days after mailing or personal delivery of written notice of default as specified herein, the \$10.00 penalty discussed in Paragraph A of this subsection shall be assessed. A \$10.00 penalty shall continue to be assessed monthly until the entire balance, including dues, penalties, and special assessments is paid in full. Failure to pay a scheduled installment as specified in this subsection, within 5 days of its due date, shall constitute default. The Association reserves the right to serve written notice of default at any time after said default, and failure to do so immediately, or acceptance of late payments, shall not constitute a waiver of this provision or any rights contained herein.

Proposed Change**ARTICLE IV—DUES, SPECIAL ASSESSMENTS, ASSESSMENTS, AND PENALTIES**

A payment plan, in writing and signed by the member and the Treasurer, may be entered into, to arrange payment of dues and special assessments, assessments, and penalties in installments over a specific period of time, and at intervals. In order to be valid under this subsection, such payment plan must contain the specific dates upon which payments are due, and the precise dollar amount due on each date. The Association reserves the right to serve written notice of default at any time after said default, and failure to do so immediately, or acceptance of late payments, shall not constitute a waiver of this provision or any rights contained herein.

As of 01/03/2016 Reads:

Any property owner or guest(s) found to violate Leisure Lake's NLV registration, flag, muffler, license, or speed limit rules and regulations while operating on association roads or property may have these privileges revoked by the Executive Board. The Board may also issue a warning or may impose **a special assessment** against the responsible LLPOA member not to exceed \$50.00 for each violation reported as documented by Security.

Proposed Change

Any property owner or guest(s) found to violate Leisure Lake's NLV registration, flag, muffler, license, or speed limit rules and regulations while operating on Association roads or property may have these privileges revoked by the Executive Board. The Board may also issue a warning or may impose **an assessment** against the responsible LLPOA member not to exceed \$50.00 for each violation reported as documented by Security.

Lake Management Report Spring 2016

As I sit here writing this article, I look outside and see many changes slowly taking place- birds I haven't seen in months are here, ice melting from the lake and a thick layer of mud forming on my vehicle. All of this can only mean one thing- Spring has arrived at Leisure Lake! While I enjoy looking at these harbingers of spring, I take time to reflect on the progress made by our Lake Management Committee since last fall. Perhaps our greatest accomplishment was the repair of the Paul J. leak. For those of you not familiar with this leak, it is north of the spillway. Mainline Excavating did this repair in November. We were able to greatly reduce this leak to levels not seen since the mid 1970's! While they were here, Mainline also completed work on the point leak. This repair is located on the point at the West end of the dam. Our most recent project was the construction of an Osprey nest tower on Island #2 at the West end of the lake. To save space, I won't go into a lot of details on this project. I would encourage all members to visit our official website for photos and details on this and other projects. We have several projects slated for completion this summer. This will include the redesign and reconstruction of the West spillway on silt pond K-1, reconstruction of K-1A and K6. We will also be repairing and extending the stand pipe on K-2. We are also in the process of getting an estimate for the repair of the cave leak. There has been an ongoing battle to repair this leak for many years. I will remind everyone again that it is not possible to guarantee success on any leak repair. However, I will state that I am fairly confident that the methods used on the other leaks will also work on this leak. We hope to have this project completed sometime in 2017, or as funding allows. I guess that's all I have for now. Like I said in the beginning, it's a nice day.

I think I'll go outside and enjoy it - maybe I'll even wash my car. Del Bischoff
